And to live by the Girl Scout Law.

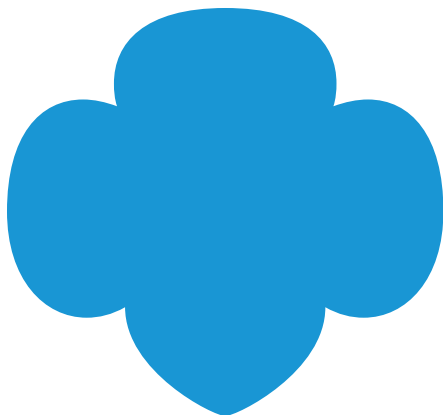
*\*Members may substitute for the word God in accordance with their own spiritual beliefs.*

## As a caregiver of a Girl Scout, I agree to:

- Recognize that Girl Scouting is girl-led, so I will uphold the Girl Scout Promise and Law by demonstrating positive support and respecting the opinions and goals of my Girl Scout and other Girl Scouts.
- Support the volunteers who are working with my Girl Scout in order to encourage a positive and enjoyable Girl Scout Leadership Experience for all. I will make every effort to attend any required family meetings and adhere to deadlines.
- Submit requested permission forms, dues, and/or materials on time, ensure that my Girl Scout is prepared for activities, and drop her off and pick her up on time.
- Support the Girl Scout efforts to provide an environment of acceptance for all Girl Scouts and their families by modeling respect towards others.
- Communicate any concerns that I may have directly to the volunteer responsible for the activity that my Girl Scout is participating in private (not in the presence of the girls, other caregivers, or on social media) and follow the GSNEO Conflict Management process if necessary.
- Not initiate or participate in gossip or negative statements about Girl Scouting and will refrain from behavior that my undermine the leadership of a Girl Scout activity or the troop/group. Should I have a complaint or problem, I will share a suggested solution.
- Follow safety guidelines for all activities and refrain from the use of drugs, alcohol, and smoking/vaping/tobacco products at all Girl Scout events.
- Support my Girl Scout's participation in product programs and follow the GSNEO requirements.
- Acknowledge that there are a variety of ways for girls and adults to participate in Girl Scouting. If I, or council staff, feel that a different participation option would be best for my Girl Scout, staff will assist in engaging her in those activities.
- Understand that to participate as a volunteer (Troop Leader, Troop Admin, Troop Helping Hand, Troop Field Trip Driver, Troop Treasurer, etc.) I must become a member of Girl Scouts of the USA and pass a criminal background check.

**I understand that my behavior directly impacts my Girl Scout's ability to participate in a troop/group or other Girl Scout activities. I will honor this agreement and follow GSNEO Member & Volunteer Policies so that my Girl Scout can have a high-quality experience. I will follow the guidelines in this agreement and support my girl by helping her to honor the Girl Scout Code of Conduct Agreement.**
